- 1593 APPROPRIATING FUNDS FOR OPERATIONS AND CAPITAL EXPENDITURES IN THE CURRENT EXPENSE, STREET, CEMETERY, C.D.B.G., WATER/SEWER, IRRIGATION, GARBAGE AND EQUIPMENT RENTAL FUNDS AND AMENDING THE 2000 ANNUAL BUDGET

- 1613 PROVIDING FOR THE ANNEXATION OF CERTAIN REAL PROPERTY TO THE CITY OF GRANDVIEW PURSUANT TO THE PETITION METHOD, AND INCORPORATING THE SAME WITHIN THE CORPORATE LIMITS THEREOF, PROVIDING FOR THE ASSUMPTION OF EXISTING INDEBTEDNESS, REQUIRING SAID PROPERTY TO BE ASSESSED AND TAXED AT THE SAME RATE AND BASIS AS OTHER PROPERTY WITHIN SAID CITY, ADOPTING A COMPREHENSIVE LAND USE PLAN, AND CHANGING THE OFFICIAL ZONING MAP OF THE CITY (EUGENE FLOYD ANNEXATION)
