This item was previously discussed at the June 13, 2017 Committee-of-the-Whole meeting, the June 27, 2017 regular meeting, and the July 11, 2017 and July 25, 2017 Committee-of-the-Whole meetings.

Parks & Recreation Director Carpenter and City Administrator Arteaga advised that following the July 25, 2017 C.O.W. meeting, they met with Phillip Winterholler to discuss the option of obtaining a permanent easement rather than a license agreement for the Memorial Plaza. Mr. Winterholler was receptive to a permanent easement.

Councilmember Moore moved and Councilmember Rodriguez seconded to approve Resolution No. 2017-32 authorizing the Mayor to sign a License Agreement between Phillip Winterholler and the City of Grandview for the Memorial Plaza. All councilmembers voted in opposition and the motion failed.
