#### **PARK CODE**

Please read the following sections of the Grandview Municipal Park Code. As organizer of your respective group, it shall be your responsibility to inform the members of your group about the Park Code. The City's Parks and Recreation facilities belong to you and we must all work together to make them a pleasant and safe place for everyone. For more information, please call 882-9219.

- <u>12.20.050 Defacing Property</u>: It is unlawful to remove, destroy, mutilate, or deface any structure, monument, statue, vase, fountain, wall, fence, railing, vehicle, bench, shrub, tree, fern, plant, flower, lighting system, or sprinkler system or other property lawfully within the park.
- <u>12.20.060</u> Animal at Large: It is unlawful to allow or permit any animal in any park, or enter any swimming pool or wading pool or stream within the park.
- <u>12.20.070</u> Explosives or Weapons: It is unlawful to shoot, fire, or explode any firearm, fireworks, firecracker, torpedo, or explosive of any kind or to shoot or fire any air gun, bows and arrows, BB gun or use any slingshot in any park, expect for professional fireworks displays allowed under this code and except for law enforcement personnel.
- <u>12.20.080 Collections and Solicitations</u>: It is unlawful to take up any collections, or to act as or ply the vocation of solicitor, agent, peddler, fakir, mendicant, beggar, strolling musician, organ grinder, extorter, barker, showman, or bootblack; or to operate or use any loudspeaker without written permit in any park.
- <u>12.20.090 Concessions</u>: It is unlawful to sell refreshments or merchandise or to distribute literature in any park, without the permission of, or a concession contract with, the city of Grandview.
- <u>12.20.100 Riding Animals</u>: It is unlawful to have or ride any horse, mule or other riding animal, except over bridle trails and other designated areas.
- <u>12.20.110</u> Alcoholic Beverages: It is unlawful to consume, possess or bring to cause to be brought, wine, beer or any other alcoholic beverage in or into any park except as provided in Chapter 5.50 GMC.
- 12.20.130 Hours: No person shall be in any park after 6:00 p.m. during the winter season, October 1st through March 1st, or after 10:00 p.m. during the summer season, March 2nd through September 30th, unless in attendance at regularly permitted activity under permit of the parks and recreation department. The time referred to above shall be daylight savings time or Pacific Standard Time, whichever is in effect on the date in question.
- 12.20.150 Vehicles and Horses: It is unlawful to ride or drive any bicycle, tricycle, motorcycle, motor vehicle, horse or pony over or through any park except along and upon the park drives, parkways, park boulevards or at a speed in excess of fifteen miles per hour, or to stand or park any vehicle, except in areas designated by the parks and recreation department.
- <u>12.20.160 Camping</u>: It is unlawful to camp in any park, except at places set aside for such purposes by the parks and recreation department and so designated by signs.
- <u>12.20.170 Refuse</u>: It is unlawful to throw any refuse, litter, broken glass, crockery, nails, shrubbery, trimmings, junk or advertising matter in any park or to deposit any such material therein except in designated receptacles.
- <u>12.20.180</u> Competitions: It is unlawful to engage in, conduct or hold any trials or competitions for speed, endurance, or hill climbing involving any vehicle, boat, aircraft or animal in any park, except in areas designated by the parks and recreation department and so posted.
- 12.20.190 Fires: It is unlawful to build any fires in any park, except in areas designate by the parks and recreation department.
- <u>12.20.200 Violation Rules and Regulations</u>: It is unlawful to violate or fail to comply with any park rule or regulation duly adopted and posted by the city.

#### PARK PERMIT

12.20.070 Explosives or Weapons: It is unlawful to shoot, fire or explode any firearm, fireworks, firecracker, torpedo, or explosive of any kind or to shoot or fire any air gun, bows and arrows, BB gun or use any slingshot in any park, expect for professional fireworks displays allowed under this code and except for law enforcement personnel.

<u>12.20.080 Collections and Solicitations</u>: It is unlawful to take up any collections, or to act as or ply the vocation of solicitor, agent, peddler, fakir, mendicant, beggar, strolling musician, organ grinder, extorter, barker, showman, or bootblack; or to operate or use any loudspeaker without written permit in any park.

<u>12.20.090 Concessions</u>: It is unlawful to sell refreshments or merchandise or to distribute literature in any park, without the permission of, or a concession contract with, the city of Grandview.

<u>12.20.100 Riding Animals</u>: It is unlawful to have or ride any horse, mule or other riding animal, except over bridle trails and other designated areas.

<u>12.20.110</u> Alcoholic Beverages: It is unlawful to consume, possess or bring to cause to be brought, wine, beer or any other alcoholic beverage in or into any park except as provided in Chapter 5.50 GMC.

12.20.130 Hours: No person shall be in any park after 6:00 p.m. during the winter season, October 1<sup>st</sup> through March 1<sup>st</sup>, or after 10:00 p.m. during the summer season, March 2<sup>nd</sup> through September 30<sup>th</sup>, unless in attendance at regularly permitted activity under permit of the parks and recreation department. The time referred to above shall be daylight savings time or Pacific Standard Time, whichever is in effect on the date in question.

<u>12.20.150 Vehicles and Horses</u>: It is unlawful to ride or drive any bicycle, tricycle, motorcycle, motor vehicle, horse or pony over or through any park except along and upon the park drives, parkways, park boulevards or at a speed in excess of fifteen miles per hour, or to stand or park any vehicle, except in areas designated by the parks and recreation department.

<u>12.20.160 Camping</u>: It is unlawful to camp in any park, except at places set aside for such purposes by the parks and recreation department and so designated by signs.

<u>12.20.170 Refuse</u>: It is unlawful to throw any refuse, litter, broken glass, crockery, nails, shrubbery, trimmings, junk or advertising matter in any park or to deposit any such material therein except in designated receptacles.

12.20.180 Competitions: It is unlawful to engage in, conduct or hold any trials or competitions for speed, endurance, or hill climbing involving any vehicle, boat, aircraft or animal in any park, except in areas designated by the parks and recreation department and so posted.

12.20.190 Fires: It is unlawful to build any fires in any park, except in areas designate by the parks and recreation department.

 $\underline{12.20.200\ \text{Violation}-\text{Rules}}$  and Regulations: It is unlawful to violate or fail to comply with any park rule or regulation duly adopted and posted by the city.
