## 4. <u>NEW BUSINESS</u>

#### A. Alice Grant Learning Center Roof Replacement

City Administrator Arteaga explained that in 1990, the City applied for and was awarded a Community Development Block Grant through the Washington State Department of Commerce to construct a learning center. The City constructed the Alice Grant Learning Center at 1005 Grandridge Road and leased the building to the Washington State Migrant Council to operate a learning center. A copy of the current lease with Inspire Development Center (formerly Washington State Migrant Council) for the Alice Grant Learning Center was provided. Staff was contacted by Nathan Radach, Facilities Manager with Inspire indicating that the roof on the main building was in need of replacement. The roof was 28 years old and with the recent windstorms, several shingles had blown off. Staff obtained three written bids in the amounts of \$22,532.16, \$29,160.00 and \$35,725.00. There were funds available in the Capital Improvement Fund. In order to complete the roof replacement, a budget amendment would need to be adopted to identify this project in the Capital Improvement Fund.

Discussion took place.

On motion by Councilmember Everett, second by Councilmember Rodriguez, the C.O.W. directed staff to prepare a budget amendment to accept the low bid in the amount of \$22,532.16 for the Alice Grant Learning Center Roof Replacement for consideration at the July 10, 2018 regular Council meeting.
