ITEM HISTORY (Previous council reviews, action related to this item, and other pertinent history)

Grandview Municipal Code Section 13.12.130 requires an Industrial Wastewater User Contract for each large industrial user. The contract includes a Schedule "A" attachment that identifies maximum loading limits for flow, BOD and TSS. The code also allows a one year trial period in order for the new industry to finalize their loading limits before the contract is formally approved by Council. The one year trial period allows a new industry to work through the growing stages without requiring the City to over allocate unused capacity.

ITEM COMMENTARY (Background, discussion, key points, recommendations, etc.) Please identify any or all impacts this proposed action would have on the City budget, personnel resources, and/or residents.

Welch Foods, Inc., has undergone a major facility upgrade to include combining Plant 1 and Plant 2 discharge points for BOD, TSS and flow to a single discharge point. The combination of the two discharge points does not change any of the monthly allocations to the Wastewater Treatment Plant as identified on Welch's previous Schedule A, however, the Department of Ecology requested a revised Schedule A now that the facility upgrades are complete.

WHEREAS, the operation of this Facility is subject to the laws and regulations of the United States and of the State of Washington including, without limitation, laws and regulations relating to discharge of industrial wastewater as administered by the Washington State Department of Ecology (WSDOE), which issues permits to both the City and to the user; and,

WHEREAS, the capacity of the facility shall be defined by the WSDOE approved engineering report and as specified within the waste discharge permit issued to the City; and,

WHEREAS, a portion of the Facility capacity shall be allocated to an industrial user under contract; and,

WHEREAS, said industrial user shall be required to enter into a contract with the City of Grandview prior to discharge to the City wastewater treatment facility,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRANDVIEW, WASHINGTON, as follows:

The Mayor is hereby authorized to sign an Industrial Wastewater User Contract Amendment with Welch Foods, Inc., for the discharge of industrial wastewater to the City of Grandview Wastewater Treatment Plant in the form as is attached hereto and incorporated herein by reference.

Good Morning YVCOG'ers:

YVCOG is pleased to announce the 2025 Congestion Mitigation & Air Quality (CMAQ) and Carbon Reduction Program (CRP) Call for Projects.

Both federal program's primary goal is to improve air quality in our region. Congestion Mitigation, while less of a factor in Yakima's metropolitan area, remains an area of potential improvement based on each jurisdiction's traveling environment.

Both WSDOT and FHWA guideline documentation have been attached for your review in considering your projects.

CMAQ – Intended to address Carbon Monoxide (CO) and Particulate Matter of 10 microns or less (PM10) within specifically defined areas in the metropolitan area for nearly 30 years. Starting with this call, project(s) eligibility for CMAQ funds have expanded to the entire Yakima Valley Metropolitan Planning Organization (MPO) boundary. Eligible jurisdictions for this CMAQ Call are: Moxee, Selah, Yakima (city), and unincorporated [urbanized] Yakima County. PM10 projects may be located within either the [historic] PM10 or the MPO Boundary (see map, attached). YVCOG is currently anticipating approximately \$2,000,000 (after other program commitments) in funding from Federal Fiscal Years (FFY) 2024, 2025, and 2026.

Application limits for CMAQ funds are new [different] this year. \$500,000 limit for equipment, programs, transit, or transit demonstration-type projects. \$750,000 limit for construction projects (alley paving, gravel road paving, signal sequencing)

CRP – CRP is a new funding source created to reduce carbon emissions, unlike CMAQ, funding is available to all jurisdictions with Yakima County, but is distributed per US Census/FHWA city population classifications.

- Medium Urban: Moxee, Naches, Selah, Union Gap, Yakima (city), metropolitan Yakima County
- Small Urban: Grandview, Sunnyside, Toppenish, Wapato & their urban growth areas (Yakima Co.)
- Rural: Granger, Harrah, Mabton, Tieton, Zillah & rural Yakima County
- "Anywhere": funding can be split into any or all of the other three classifications.

YVCOG anticipates over \$3,000,000 in CPR funding to be available countywide. Anticipated classification distributions are outlined in the application packet. **Project cost limits are \$500,000**, but smaller priced projects are encouraged. Eligible CRP projects include projects to replace lighting and traffic control devices with energy efficient alternatives, "Transportation Alterative" project(s) eligible under 23USC101(a)(29), or "Public Transportation" project(s) eligible under 23USC142. Non-Profit organizations may also be eligible for funding but **must** partner with a Yakima County region jurisdiction [bullet] listed above.

ADDITIONAL INFO

CMAQ and CRP projects will be processed through federal/state authorized emissions tools to determine air quality benefits. The significance of these benefits will be a primary factor in prioritizing funding award. To prioritize air quality benefit analysis, jurisdictions are requested to submit this notice of intent along with your intended project description. Please complete this document and return by December 20th.

Both CMAQ and CRP awards anticipate utilizing state toll credits to meet the federally required 13.5% match requirements.

The application packet includes a two-page letter of intent, preceding the primary application document. Applicants MUST submit their intent letter to YVCOG no later than **Friday**, **December 20**th, (email preferred, please). YVCOG staff will utilize project information provided by the applicant to model air quality benefits (if appliable). This "benefit finding" information will be provided to the applicant for inclusion into their final application submittal. Applicant projects that expect to reduce **vehicle miles traveled** (VMT) will need to provide supporting information to those reductions in their final submittal. Applications without a submitted Intent Letter, even if no modeled findings are determined, will not be considered.

Intent letters may be signed by staff or program leads. Final applications MUST be signed by the project's jurisdiction/agency lead AND by a jurisdiction's elected official or agencies executive authorized to sign agreements or grant applications.

Proposals must include the following to be considered:

- A completed and signed application can be electronic or handwritten (signed)
- One-page project vicinity map (8.5" x 11" or 11" x 17")
- Any necessary supporting documentation

Project Description	

The City of Grandview currently uses a 23-year-old street sweeper which is nearing the end of it's serviceable life. The EPA suggests that the current average lifespan of a street sweeper is 5-8 years, depending on usage. The environment for which a sweeper operates wears on all components, and its efficiency decreases, especially compared to the new sweepers equipped with more advanced technology. The request for a modern street sweeper would decrease diesel emissions, resulting in a reduction of carbon and air pollution emissions (PM₁₀).

By purchasing a new street sweeper, the City would reduce diesel, carbon, and nitrogen emissions, while also cutting the additional yearly maintenance expenses and continuing to keep streets clean.

The City currently has 94.3 lane miles of roadway that should be regularly swept. Street sweeping improves air quality in the PM_{10} maintenance area, reduces the amount of trash and debris on our roadways, and enhances water quality. An emission-friendly sweeper would significantly amplify these benefits.

*Projects demonstrating an air pollution reduction other than PM₁₀ may submit a 2025 application according to consensus between YVCOG and WSDOT as of October 4, 2012. Air Quality Benefits (Enter Text Here):

The City of Grandview currently contains 47.15 linear miles of streets, which the City sweeps two days a week, for approximately 8 hours each day. The reduction in diesel emissions provided by a new street sweeper will significantly improve air quality and help to reduce the PM₁₀ Region.

A new street sweeper equipped with a diesel emission system offers the greatest benefit in reducing diesel emissions. This system uses a diesel oxidation catalyst to raise exhaust gas temperatures, which helps reduce carbon monoxide and hydrocarbons. Next, a diesel particulate filter captures and stores emitted debris until the regeneration conditions are optimal. The exhaust is then treated with diesel exhaust fluid before entering the selective catalytic reduction, where any remaining nitrogen oxide emissions are removed.

In addition to reducing emissions, a street sweeper will continue to decrease the number of organic particulates on the streets that are resuspended into the air by traffic. Other contaminants such as asbestos and heavy metals from brakes and leaking fluids are also resuspended in air or washed into the storm systems. A reduction in air pollution within the City of Grandview would benefit both residents and visitors.



Currently, the Public Works Director position has eight (8) direct reports across all divisions. I'm proposing a new structure where the department director only has four (4) direct reports, which is the industry standard.

The Assistant Public Works Director position will be retitled as the Public Works Facilities Supervisor, with a new job description attached herein. The Public Works Foreman position will be retitled as the Public Works Utilities Supervisor, with a new job description attached herein. Each of these new positions will have assigned staff to perform the work within each new division.

The Public Works Facilities Supervisor will oversee all city facilities: parks, streets, buildings and structures.

The Public Works Utilities Supervisor will oversee specific city utilities: water, garbage, irrigation and stormwater.



ARPA Project Update

Amphitheatre Events – Finn Styles Company was awarded the \$20,000 to put on two (2) events in 2025 at the Childress Amphitheater. We have not confirmed the dates for the events but the theme for the spring event is a BBQ Competition/ Cook-Off, and the second event is the Dia de los Muertos celebration.

Skatepark – We are under contract with American Ramp Company to design a skatepark. They sent out a community survey that we posted on social media to gather feedback from the community and the skaters on what they would like to see at the new skatepark. Once they have tabulated the feedback, they will put together a few conceptual designs for us to review and share with the community. A final design concept will be decided based on community feedback, and of course the costs of constructing it. That said, we do not have a funding source in place to construct the skatepark.

Splash Pad – HLA is working on the splash pad design. We are planning to go to bid on the construction in late winter or early spring. The goal is to have it operational by this summer.

Lower Valley Pathway – The pathway project is substantially complete with a few small items that still need to be done this spring. The project was completed on time and under budget.

Sensory Playground – The sensory playground has been ordered and should be delivered in the next month or so. The playground will be located at Dykstra Park on the West 5th Street end of the park. This site was selected because of the proximity to the restrooms and the existing pathway serves as our ADA access to the playground area. This reduces our costs significantly. I'm waiting for a schedule from the installer on timing.

Pickleball Courts – We constructed two (2) courts at Westside Park and two (2) courts at Eastside Park. The lines will be painted this spring when the weather warms up.

Childress Amphitheater – Equipment has been ordered for the new sound system at Country Park. Avidex will begin installation on March 3, and should be completed by mid-March.

Marketing Materials — We are under contract with Pixelsoft to create marketing brochures and flyers for future development of business and industries. They will be putting together information for us to share with our elected officials when we attend the AWC City Action Days in February. We will also be editing the video on our website in the next few weeks.
